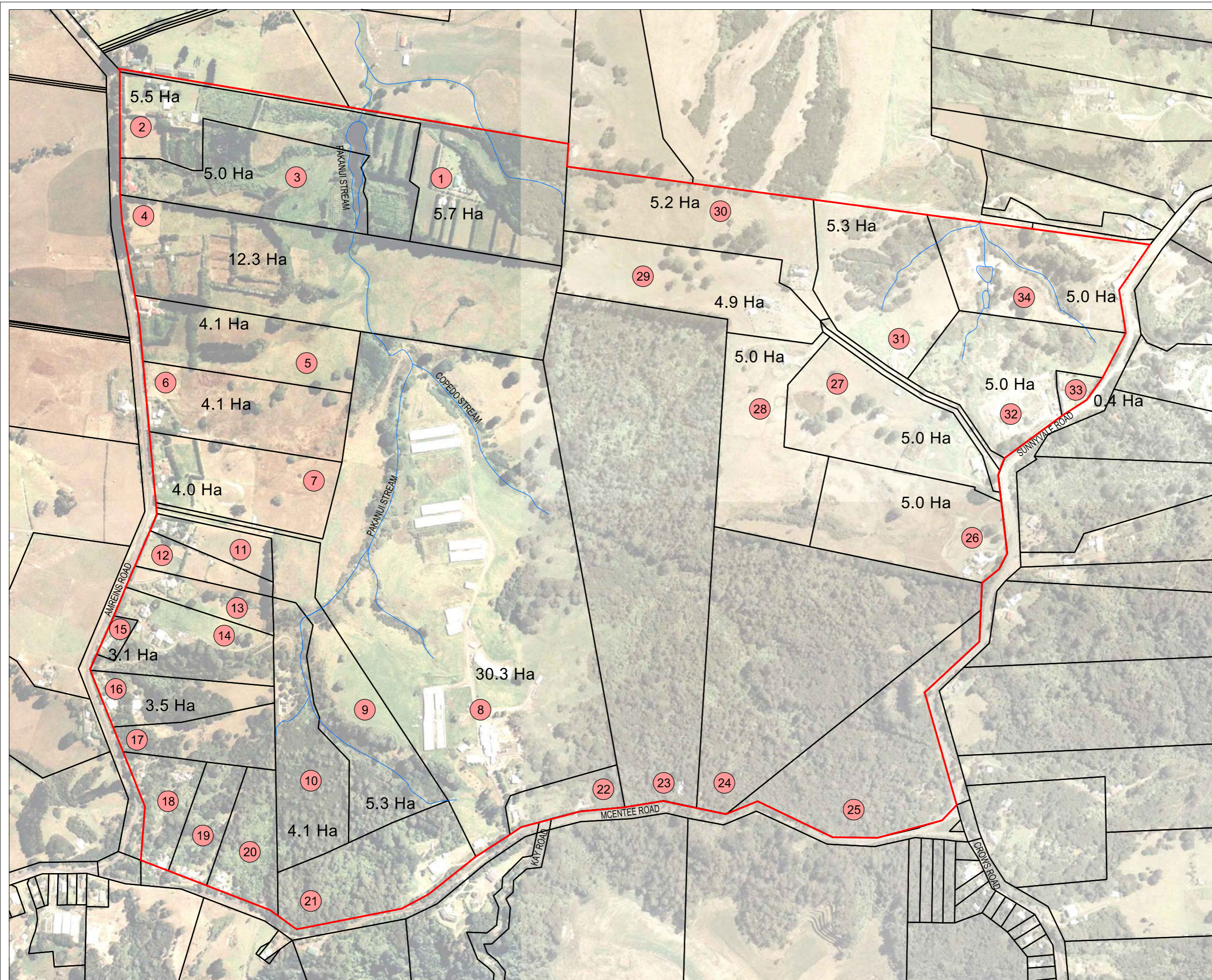


Appendix 2 – Pakinui Landowner/Property Details
