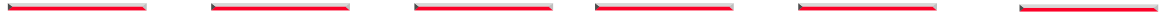

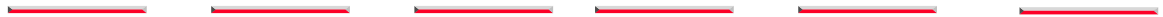
5 PRESENTATION - ASPIRING LEADERS FORUM
