- (ii) Full particulars of the proposed changes will be provided at any hearing of the Plan Change.

1.5 The changes sought will be discussed in the following sections of this submission. Note that additions are underlined and deletions are ~~struckthrough~~.

2. General Submissions Relating to Plan Change 22

2.1 Typographical Errors

2.2 Proposed Plan Change 22 contains a number of typographical and editorial errors, and also has on occasion used incorrect words. This leads to a lack of clarity for Plan users, and requires amendment to improve the clarity and effectiveness of the Proposed Plan Change. These amendments are listed in Appendix A of this submission.

2.3 Relief Sought

Amend the Plan Change 22 in accordance with the relief sought as detailed in Appendix A.

4. My submission seeks amendments to the following Definitions and Rules within Proposed Plan Change 22.

4.1 Rules Volume 1 – Definitions and Rule Volume 2 – Special Areas Rule 29 Rule 1.2

The definition of Airport Activities within Rules Volume 1 and repeated again in Rules Volume 2 Special Area Rule 29 Rule 1.2 contains an error in the wording with reference to convenience shops, which could result in mis-interpretation and would be inconsistent with the subsequent parts of the definition. The intention of this part of the definition is to limit the size of shops to less than 100m², however the wording that “no one shop may not exceed 100m² in gross floor area” could be interpreted as requiring all shops to exceed 100m². Therefore to ensure clarity of the definition and to ensure consistency with the rest of the definition, the word “not” should be deleted from the bullet point relating to convenience shops.

The last bullet point in the definition allows for “Dwellings for persons whose employment duties require them to live on the premises”. Proof that the dwellings are only for persons who are required to live on the site is difficult for applicants to provide in an application for Resource Consent and for Council to control or enforce on an on-going basis. As such the wording should be altered to require that any dwelling is subsidiary to an Airport Activity. The District Plan currently contains the following definition of subsidiary as “assisting in the operation of a larger activity”. This would encompass a situation where persons were required to live on site and ensure that the dwelling would be secondary to, smaller than and assisting in the operation of another Airport Activity. It is appropriate for applicants to show that a dwelling is subsidiary to another activity, rather than to show that a persons employment requires them to live on site. Subsidiary also relates to the physical characteristic, design and use of the proposed building, not its occupants current employment status.

4.2 Relief Sought

Amend Rules Volume 1 – Definitions and Rule Volume 2 – Special Areas Rule 29 Rule 1.2 as follows (additions underlined and deletions ~~struck through~~). Note the addition of the superscript m² as per Appendix A..

Airport Activities means :-

- *Activities* involving aircraft using the airport (including maintenance);
- Airport Operational *activities* (i.e. runways, traffic control and meteorological structures, emergency services, terminal buildings, custom and quarantine facilities, aircraft refuelling facilities and aircraft hangars);
- *Buildings* and *activities* associated with the freighting of goods by air;
- Vehicle Parking and Access;
- *Convenience shops* servicing air travel needs, such as cafés, general refreshment stores, newspaper kiosks, ticketing agents and rental car companies, provided that no one *shop* may not exceed 100m² in *gross floor area*;
- *Retail activities* involving the sale of duty-free goods, provided that no one *shop* may exceed 100m² in *gross floor area*;
- *Telecommunication* facilities; and
- *Dwellings which are subsidiary to other Airport Activities.*

4.3 Rule 29.5(b) and Rule 29.5(c)

Rule 29.5 (b) and (c) are both Discretionary Activities. An application for an Amendment to an approved Airport Comprehensive Development Plan Activity should be subject to the same information requirements as a fresh application for an Airport Comprehensive Development Plan. As such an application for an amendment should be combined into Rule 29.5(b).

Rule 29.3 (b) states that "Any Airport Activity, including any building or addition to a building, which is in accordance with an Airport Comprehensive Development Plan" shall be a Limited Discretionary Activity and that performance standards against which these applications will be assessed will be "as prescribed in an ACDP as approved pursuant to Rule 29.5(b)". Therefore Rule 29.5(b) should include a requirement to provide details of the proposed standards against which subsequent Limited Discretionary Activities will be assessed.

4.4 Relief Sought:

Alter the wording in Rule 29.5(b) as follows and delete Rule 29.5(c) (additions underlined and deletions ~~struckthrough~~). ;

(b) An Airport Comprehensive Development Plan (ACDP) and any subsequent amendment to a ACDP which provides for the whole of the *Whenuapai Airport Special Area* and includes:-

4.5 Relief Sought:

Include an additional requirement 29.5(b)(x) as follows (additions underlined and deletions ~~struckthrough~~). ;

(x) Details of the proposed Performance Standards against which any subsequent Limited Discretionary Activity application to establish any Airport Activity pursuant to Rule 29.3 (b) will be assessed.

4.6 Rule 29.6(c)

Rule 29.6(c) does not specifically limit its application to an Airport Activity or Operator allowed by an approved Airport Comprehensive Development Plan and therefore could be interpreted as applying to the NZDF. The wording of the rule

should be clarified to only apply to an Airport Operator for an Airport approved via an Airport Comprehensive Development Plan.

4.7 Relief Sought

Either alter the wording of Rule 29.6(c) as follows (additions underlined and deletions ~~struckthrough~~). ;

"For the purpose of this control the airport operator shall annually provide to the Council's Manager, Resource Consents the result of calculations performed by an accredited acoustic consultant based upon monitored aircraft movements for the preceding year and the known noise characteristics of those aircraft. The calculations shall be in accordance with the Noise Management Plan required by Rule 29.5(b) of these rules."

Or

Add the following statement at the start of the rule as follows;

"29.6 Aircraft Noise

This rule shall apply to all Aircraft Activities and operations allowed by an approved Airport Comprehensive Development Plan.

(a) Aircraft operations allowed by an approved Airport Comprehensive Development Plan shall not exceed ..."

5. My submission seeks amendments to the following Assessment Criteria within Proposed Plan Change 22:

5.1 There is inconsistent reference to the "Airport Comprehensive Development Plan" and the "Comprehensive Development Plan". It is submitted that the assessment criteria should all refer to the Airport Comprehensive Development Plan.

In addition an amendment to an approved Airport Comprehensive Development Plan is a Discretionary Activity and therefore Assessment criteria 29(b) should clearly apply to proposed ACDP and any subsequent amendments to an ACDP.

5.2 Relief Sought:

Alter the wording in Assessment criteria 29(a), 29(b), and 29(m) by adding the word "Airport" and the words "and any amendment to an approved Airport Comprehensive Development Plan" as follows;

29(a)

The extent to which any proposed Airport Comprehensive Development Plan or amendment to an approved Airport Comprehensive Development Plan is consistent with maintaining the integrity of Defence Purpose activities at the RNZAF Base, Auckland, in accordance with Designation Ref MD1.

29(b)


The extent to which any proposed Airport Comprehensive Development Plan and any amendment to an approved Airport Comprehensive Development Plan has been prepared in accordance with a consultative process that includes the local

community and other parties that may be affected by *activities* made possible by the Airport Comprehensive Development Plan.

29(m)

The extent to which *development* and airport management processes have been designed to integrate the airport with *roads*, intersections and transport systems, including provision for public transport. (Note, it is expected that in the development of a Airport Comprehensive Development Plan there will be consultation with the Auckland Regional Council, the Auckland Regional Transport Authority and Transit New Zealand).

6. **My submission seeks amendments to the following Planning Maps within Proposed Plan Change 22:**
- 6.1 Upon further discussion and assessment of the noise contours and the indicative Joint Use Scenario it appears that further analysis may be required to confirm that the location of the contours as existing are appropriate. It is also noted that the Table which appears in the S.32 Analysis and which provided the basis for the assessment of the Joint Use Scenario and potential noise effects may be incorrect. Further analysis of the noise effects and noise contours may be required to clarify this matter.
- 6.2 **Relief Sought:**
That the proposed Noise Contours, as shown on Map III are confirmed.
7. **I do wish to be heard in support of my submission.**
8. **If others make a similar submission I may be prepared to consider presenting a joint submission with them at a hearing.**
