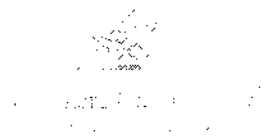

Hereby make application for an exemption from the standard fencing controls relating to pools. I propose to make or have already made the following arrangements for the security of my pool:

As per your letter 20th December the pool fencing complies and an exemption is sought for a single set of bi-fold doors only.

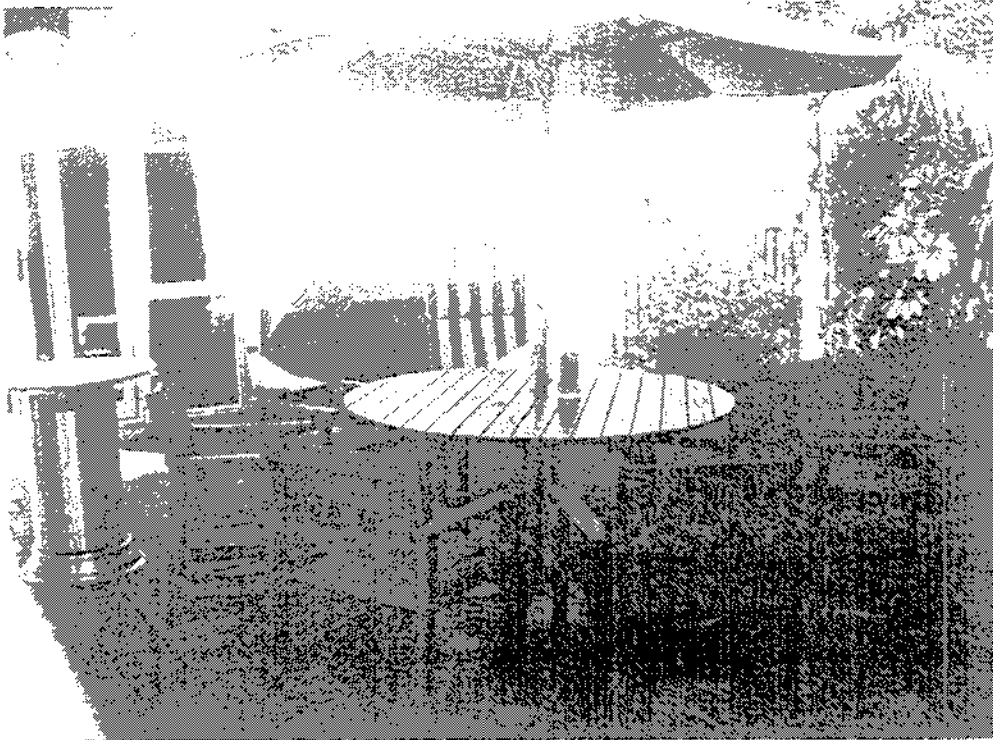
Reasons why my proposal should be granted:

1. The lounge doors are pre existing as part of the original building and form a significant part of the architecture of the home. The plan to have a pool came into action 3 – 4 years later. Because of the sewer pipe that runs across the front of the section we were forced to bring the pool back against the lounge.



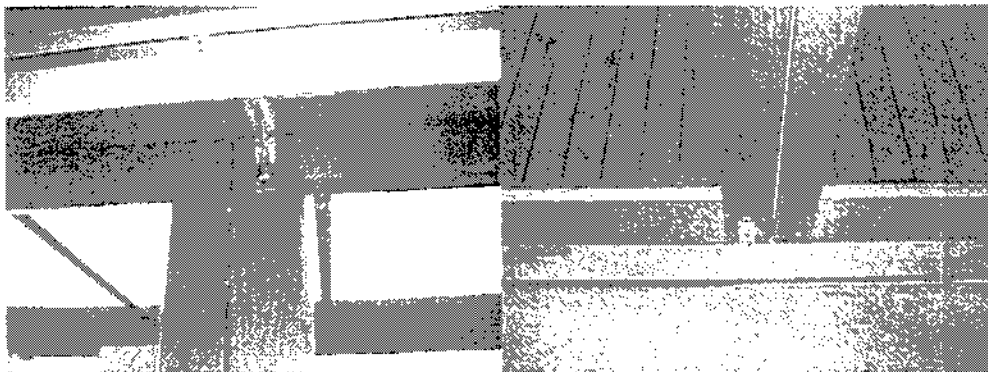
Pool area Showing Doors

2. The doors are the only point of direct access to the pool from the house i.e. there are not multiple sets of doors opening onto a pool area. As part of security for our house these doors are always locked except when the pool is in use. We have alternate outdoor living areas containing dining, BBQ etc.

3. The door panels each have locks top and bottom. The top locks are at the top of the panels over 2m high and well out of reach of a six year old. The bottom locks add security and weather proofing by holding the doors flush. All panels must be secure in order for the central hinged door to be locked. This creates the situation where you cannot leave the doors unsecured.



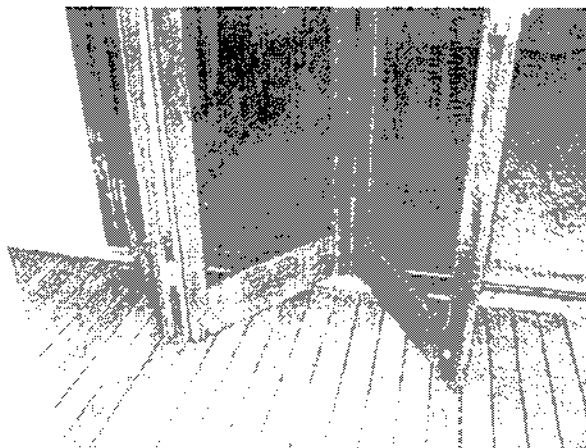
Top and bottom locks.

4. The central hinged door opens independently from the other panels and has a key lock 1.6m above floor level. One central key lock secures all the panels, so you cannot independently or inadvertently push any of the panels to open them. All top and bottom locks must then be released to open the doors.



Central door opening – all panels locked.


5. The set up of locks makes this door more secure than a Ranch Slider door due to the additional top and bottom locks on all panels. A ranch slider when open affords no additional security over and above these doors when open. The central key lock is also much more difficult to manipulate for a 6 year old than a ranch slider lever. The handle on the door must be depressed with some force to release the door once it is unlocked.



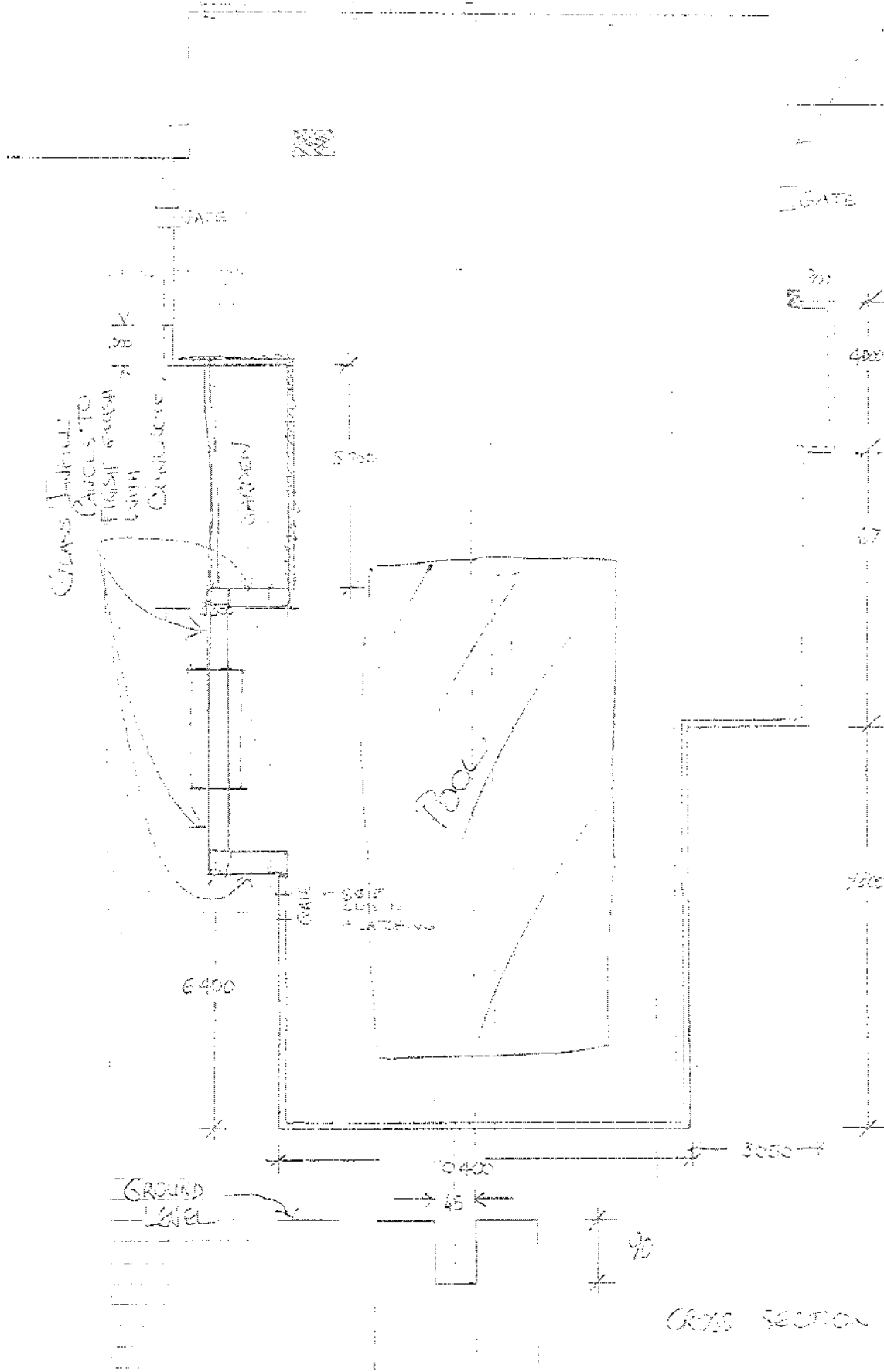
Having enjoyed a season with the doors as they currently are I am confident that we do not offer any increased risk to an under six year old at our residence. The nature of the outdoor arena means that the pool is a designated pool area with other doors leading to alternate outdoor areas.

Hereby make application for an exemption from the standard fencing controls relating to pools. I propose to make or have already made the following arrangements for the security of my pool:

Recent inspection noted that the french doors built into our changing room which open onto deck do not comply with fencing regulations (are not self-closing & latching). However, we believe these are safe as they are lockable and also have child barriers fitted into each doorway to prevent children getting through doorways if the doors are open.

Reasons why proposal should be granted: (See reverse)

An exemption/discretion was granted at the last inspection - so this would be a continuation of that, rather than a new exemption.

When we purchased the property, we ordered a pool inspection to ensure that the pool complied with regulations, and were advised that it was determined

to be safe, based on the exemption granted.

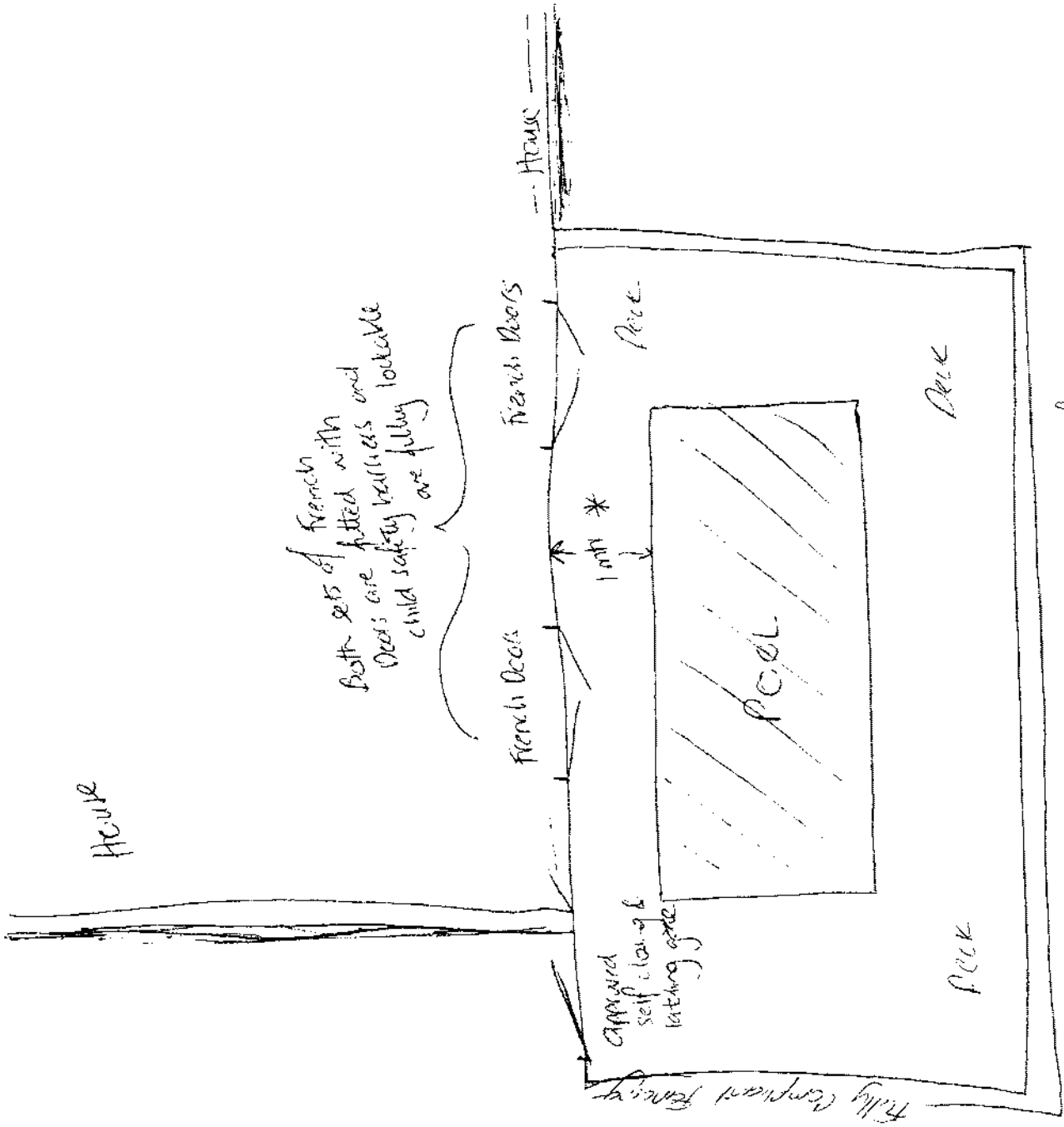

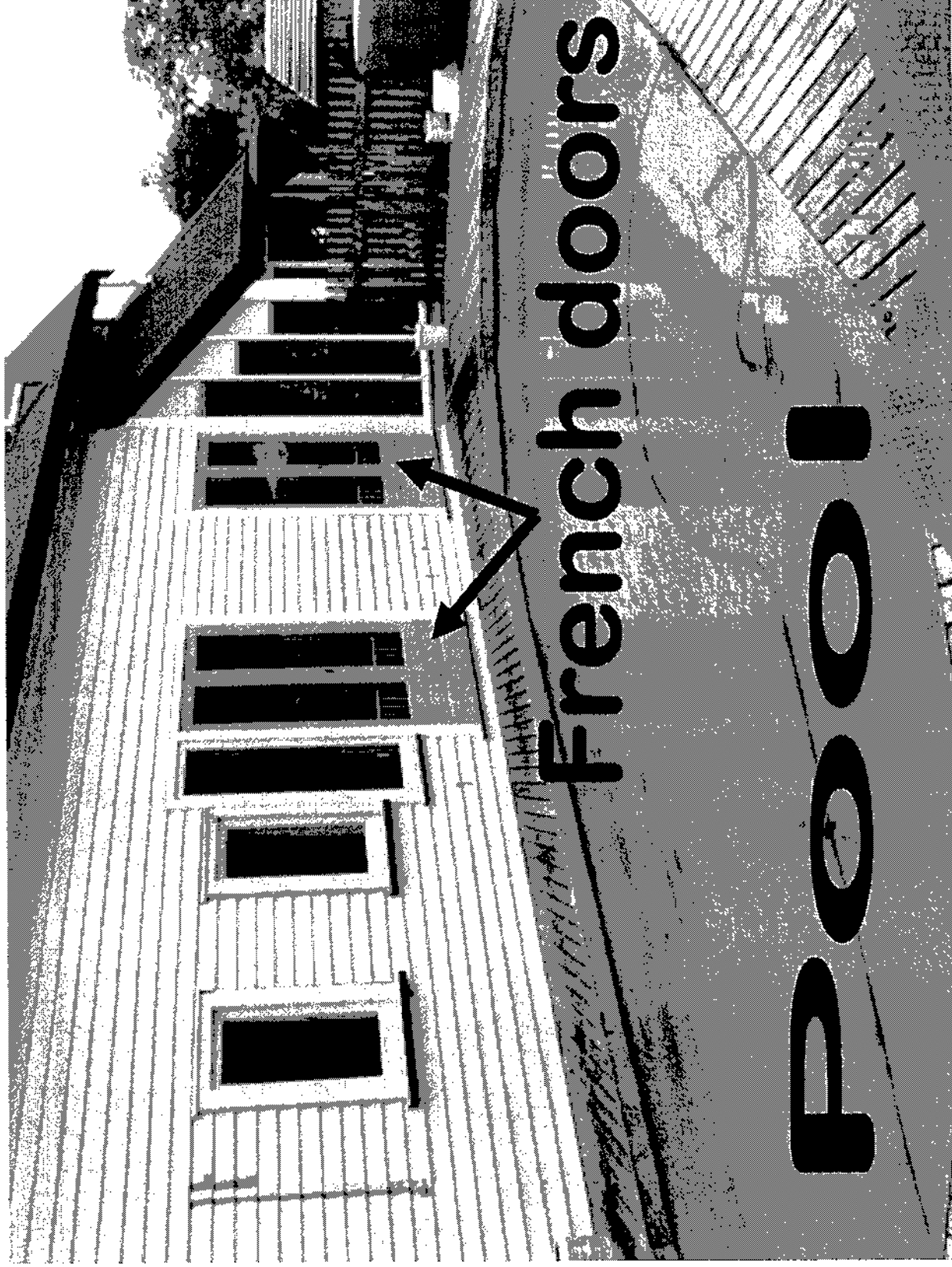
