The Regional Council (ARC) and the Ministry of Agriculture & Forestry (MAF) have responsibilities and powers under biosecurity legislation that allows them to proceed with their weed and pest control activities. They may choose to respect this Register; they are not obliged to do so.

Herbicide control is undertaken by contractors engaged by Waitakere City Council. These contractors are aware of 'NO SPRAY' addresses and when requested by the resident will contact 'NO SPRAY' residents 24 hours prior to spraying in that resident's street. It would assist the process if an answering service was available for Council's contractor to leave details of the intended spraying operation near you as only one phone call attempt to residents informing them of intended spraying will occur.
